- Chain of Command

Faction Hub Overseer.

Deputy Faction Hub Overseer.

The Overseers team comprises two ranks and two individuals: the deputy and the overseer. Their responsibility is to supervise the entire faction hub; they possess absolute authority within the Faction Hub. Their decisions may only be revoked by Site Ownership.

Can read all applications.

Faction Hub Director.

Deputy Faction Hub Director.

The Leadership Team comprises two distinct roles and two individuals: the deputy and the overseer. Their responsibility is to assist the FHO and DFHO in managing the Faction Hub. They possess nearly complete authority over the Faction Hub, although this authority does not fully equate to that of the Overseers team.

Can read all applications.

Faction Hub Manager.

Head Faction Hub Staff.

The High Ranking team or Human Resources consists of two ranks and six members: three Faction Hub Managers and three Head Faction Hub Staff.

Their Job is to read applications, help Middle and Low ranks with tickets, supervise them, issue punishments to factions that break the Faction Hub Handbook, and issue punishments, demote or remove incompetent Faction Hub Staff, approve faction rebrands, anything related to FHS, and they can deploy and help GMT freely.

HR can only read Perks and Factions applications.

Senior Faction Hub Staff.

Experienced Faction Hub Staff

The Middle Ranks consist of 2 ranks and 7 individuals: Experienced Faction Hub Staff and Senior Faction Hub Staff.

Their Job is to help low-ranking staff in all of their duties. As an MR, you can issue punishments to factions and approve punishments done by LRs, you can approve appeal strikes and warnings as well, and you have access to the database to update it when needed.

Only MR can read the perks applications.

Official Faction Hub Staff.

Junior Faction Hub Staff.

Trial Faction Hub Staff.

The Low Ranking Team consists of 3 ranks and an uncountable number of individuals: Official Faction Hub Staff, Junior Faction Hub Staff, and Trial Faction Hub Staff.

*Their "Main" job is to answer tickets and deploy in-game TFS and JFS need an MR+ to supervise them while deploying, If they want to help GMT moderate, they can deploy freely as FHS. They **CAN'T** issue punishments to factions without an MR+ approval. They can do anything with a supervisor. They can volunteer to make a new document, do the faction quota check if they were in the administration group, and OFS can accept clearances between L1-L3.*

Your Quota as an LR and an MR is 3 tickets weekly, and 2 hours in-game.
